#### Introduction of Guests / New members:

Christie Carter was recognized as a new Auxiliary member.

## Adjutant:

- a) Minutes from the 21 Jun meeting (no meeting was held on the 5<sup>th</sup> of July) were posted on the Post website and e-mail to all.
  - Alan requested the sentence listed under: "On-going Projects / Events, b), Duty Assignments, iii, a)" be deleted.
  - Motion by Barry R, second by Rex W, to accept posted minutes as amended by Adjutant's request. **Motion carried (MC)**.

#### Auxiliary Report:

 a) Dina L. reported that nominations and elections will be held at the next meeting on 2 Aug.

#### Post Finance Officers Report:

Mel C. reported the Post balance is \$2,409.88 (Auxiliary balance is \$623.00); with approximately \$7,630.14 inflow and expenses of \$8,838.84 (poker run payout). Motioned by Rick S, second by Barry R, to accept the financial report as read. MC.

### Completed Events:

- a) Post 1340's 4th of July Poker Run (99 bikes; 140 entrants)
  - Ken stated that it was a successful effort especially for the size of our organization and thanked everyone for their support.
  - Discussions were held to see if and how improvements could be made for next year. Topics discussed included: vendors, games, giveaways, sponsors, public relations, advertising, date selection, registration, stop selections and sponsors, planning and management, grand prize amount. A summary of the outcome from these discussions follow:
    - i. Improve our flyer
    - ii. Add dunk tank
    - iii. Start soliciting sponsors now and get commitments from them (pledge or promissory type note); then follow up with sponsors on a regular basis to hold them to their commitments
    - iv. Identify and publicize a more tangible goal or objective that folks and identify with
    - Motioned by Charlie W, second by Rick S, to make our goal be an air conditioning unit for installation into the Legion Children's Home gymnasium.
       MC. Ken L, will request additional information about the gym with assistance from Boyd W.
    - v. Improve promoting and advertising by working closer with radio and TV stations and starting this sooner; Billy M, has a POC at a local station that's willing to give air time to vet organizations; we should take advantage of this
    - vi. Bob H, was recognized for obtaining tables and chairs for customers to sit down and eat the food they bought from us
    - vii. Improve registrations; possibly give out pins, patches, or shirts when people preregister; this also gives our event more exposure; we could set up at bike nights or other events to do this
    - viii. Working so many events prior to the 4<sup>th</sup> was identified as a hindrance to our run; folks were getting worn down and it also took them away from concentrating on other needs to support the run
    - ix. Because the 4<sup>th</sup> is on a Tuesday next year, a motion was made by Keith C, second by Rick S, to set 2 Jul 06, for our annual poker run, with 9 Jul as a rain date. MC.
    - x. Encouragement was pushed to continue having a 4<sup>th</sup> of July run date and work on improving it for a couple more years
    - xi. Having a run in conjunction with the Veterans Day ride to the state capital was brought up; Charlie W, stated that is a day set aside for veterans and we should take advantage of it;
    - -- Motioned by Randy, second by Keith, to pursue another run on Veterans Day. Boyd identified the need to discuss with ABATE and Marine Corp League about having this event. MC.

# Ongoing Projects / Events:

## a) Annual State Legion Convention

- The support we provided with our hospitality suite was a success.

- An unfortunate event occurred while closing down the event. Jim S, was given the 50/50 container with the tickets and half of the income (\$67.50) in it. He set it aside and went on to assist with the cleaning-up and moving of post belongings. Jim accepted responsibility for the loss and stated that he would replace the money. He also requested his resignation as the Post Sergeant at Arms for personal reasons.
  - Motioned by Charlie W, second by Rick S, to not accept the lost \$67 or Jim's resignation. The tickets were lost so there is no way to complete the drawing and the lost money would not have belonged to the post anyway.
